Paddock to Reef Perceptions of Practices Survey

P2R social monitoring surveys for agricultural practice change projects

You are invited to take part in the Perceptions of Practices survey. It is important that you feel comfortable to answer the survey openly and honestly, so we have explained the purpose and use of the survey below.

What is involved?

- You will be asked some questions about your perception of the land management practices that will be covered in this project as part of the Paddock to Reef Perceptions of Practices survey on behalf of the Department of the Environment, Tourism, Science and Innovation (DETSI).
- The whole process should take no more than 15 minutes.

What is the purpose?

- We are interested in your perceptions of the land management practices that will be covered in this project as this will help us evaluate the effectiveness of water quality improvement programs through the Paddock to Reef program.

What is the data used for?

- Perceptions of Practices data is collected for Reef water quality projects or programs funded by the Queensland and Australian Government.
- Management practice information only (the geographical location of your property is not linked) is provided to the Behavioural Insights team in DETSI for the purpose of connecting practice data with Perceptions of Practices survey.
- We use the de-identified Perceptions of Practices data (i.e., no personal information is included) to support reporting of progress towards improving Reef water quality and to tailor projects to the specific challenges faced by participants. This de-identified data may also be used in publications and reports.
- De-identified data may also be used for research and in these instances may be provided to research institutions.
- We will only use your personal information for these purposes. It will otherwise not be used or disclosed unless authorised or required by law.

How is the data managed?

- Where project participants, such as yourself, have 'opted-in' to complete the Perceptions of Practices survey, de-identified data (i.e., the geographical location of your property is not linked) is provided to DETSI. The data is stored in a secure folder with limited access on secure, password protected computers.
- Your responses will be strictly confidential. Aggregated data will be used for publications and reports. You will not be identified in any way.
- Your personal information will be handled in accordance with the Information Privacy Act 2009.

- Taking part in this survey is voluntary and you can stop taking part at any time without explanation or prejudice.
